

Caribou Harvesting Gas Subsidy Application Form 2025 Behchokò Presence Office, Tłįcho Government

This program is for Tlicho citizens in **Behchokỳ** who will harvest caribou and require fuel assistance. This subsidy is available one time for one person per household.

INSTRUCTIONS: You must answer all questions in detail on this application form unless otherwise indicated. An incomplete application will delay the approval process. Submit the completed application to the Behchoko Presence Office.

- If your application is approved, you will receive a callback from our staff and a PO number will be issued to your name at our local gas station for a total of <u>\$350.00</u>
- If you haven't received a call about your application, this means your application is pending and requires more information for approval.
- If you are going to apply for a harvesting gas subsidy, you won't be eligible for the community meat distribution even if your hunt was unsuccessful.

APPLICATION PROCESS: Applications will ONLY be received between Monday & Thursday to be processed within the same week. Applications received after Thursday will be processed the following week.

- Application intake: Monday, Tuesday, Wednesday & Thursday
- Purchase Order release: Friday Afternoon between (1:00 pm 5:00 pm)
- Approval calls: Friday afternoon

If you have been approved for this subsidy, it is MANDATORY to provide receipts
