08 COUNCIL CONCERNS

a. Pole for Community Banners

Councillor Leo Nitsiza suggested adding four (4) poles to support displaying crossroad banners for special events. Administration will investigate costs and bring that information back to Council.

b. Whati Inter-Agency Presentation Report

Councillor Alex Nitsiza reviewed a Special Inter-Agency meeting held this afternoon to discus issues relating to alcohol-abuse in the community. A presentation was provided by Ms Carolyn Coey-Simpson, Nurse-in-Charge at the Whatì Health Unit, and focused on how to develop action plans to reduce, if not eliminate, the negative social impacts. Any plan, however, requires support and participation from all agencies in Whatì to be truly effective. Support for this initiative can be demonstrated by a community proclamation that Council may consider in the future.

Chief Alfonz Nitsiza expressed his concerns about alcohol abuse in the community and the negative impact on the culture and history of the Tłįchǫ people. He would like to see a community meeting and workshops in the near future to discuss this further.
