Community Government of Whati BYLAW NUMBER 62-2016

A bylaw of the Community Government of Whati in the Northwest Territories to provide for repeal of Deputy Senior Administrative Officer appointment, pursuant to the provisions of the Tłicho Community Government Act, S.N.W.T. 204, Chapter 7, Section 39.

WHEREAS the *Tłicho Community Government Act*, S.N.W.T., 2004. C.7, s.69 (1) allows the Council to repeal a bylaw;

AND WHEREAS the bylaw listed in Article 2.1 of this bylaw are no longer deemed necessary or in the best interests of the residents of the Community Government of Whati;

NOW, THEREFORE, the Council of the Community Government of Whati, in regular session, duly assembled, enacts as follows:

1.0 CITATION OF BYLAW

- 1.1 This bylaw may be cited as the "Repeal of Bylaw 56-2015 Appointment of Deputy SAO".
- 2.0 APPLICATION OF BYLAW
- 2.1. "Bylaw 56-2015, Appointment of Deputy SAO", shall be repealed.
- 3.0 GENERAL
- 3.1 This Bylaw shall come into effect upon Third and Final Reading.

COMMUNITY GOVERNMENT OF WHATI BYLAW NUMBER 56 – 2015

A bylaw of the Municipal Corporation of the Community Government of Whati in the Northwest Territories to appoint a Deputy Senior Administrative Officer, pursuant to the provisions of the *Tłicho Community Government Act*, S.N.W.T. 204, Chapter 7, Section 39.

WHEREAS Council of the Community Government of Whati deems it beneficial to create the position of **Deputy Senior Administrative Officer** as a supplementary position to that of the Senior Administrative Officer, and for purposes of providing mentoring and administrative support;

NOW, THEREFORE, BE IT RESOLVED THAT the Council of the COMMUNITY GOVERNMENT OF WHATi, at a meeting duly assembled, enacts a bylaw as follows:

SHORT TITLE

1. This Bylaw may be cited as the "Deputy Senior Administrative Officer Bylaw."

DEFINITIONS

- 2. In this Bylaw:
- 2.1 "Act" means the *Thicho Community Government Act*, being Chapter 7, of the Statutes of the Northwest Territories, 2004.
- 2.2 "Community Government of Whati" means the municipal corporation of the Community Government of Whati as defined under the *Act*.
- 2.3 "Council" means the duly elected representatives of the Community Government of Whati.
- 2.4 "Deputy Senior Administrative Officer", or "Deputy SAO", means the position established supplementary to, and under the direction of, the SAO.
- 2.5 "Senior Administrative Officer", or "SAO", means the position established by Section 38 of the *Act* and the term Senior Administrative Officer or SAO may be used interchangeably.

GENERAL PROVISIONS

- 3.1 That, effective October 1, 2015, Mr Larry Baran shall be appointed as the Deputy Senior Administrative Officer for the Community Government of Whatì.
- 3.2 The Deputy SAO may be delegated to perform some or all of the duties, and exercise some or all of the powers, as described in Section 42(2) of the *Act* as may be determined by the SAO from time to time.
- 3.3 Where the situation exists that the SAO will be absent from the community for more than five (5) consecutive working days, and the Deputy SAO is present in the community, the Deputy SAO shall be deemed to have been delegated the authority of **Acting SAO**, as per Section 30(2) of the *Act*, whether or not the SAO has made those temporary appointment arrangements previously with the Council (as per *Bylaw 31-2012, Schedule "A", Section 3.05.02*).
- 3.4 This Appointment and this Bylaw shall be automatically repealed on April 1, 2016.
