Due to short winter road season last year, taking and bringing the ATV back to and from Hay River was not feasible. Administration purchased an extra ATV as a backup for summer projects. Hence Administration purchased 2 new ATVs from Polar Tech Yellowknife. GNWT MACA is asking Community Government of Whati to council approval for the above-mentioned purchase out of CPI funds.
