# f) Capital Budget (Revised)2019-20

The following changes were made in the Capital Budget: GAS Tax:

- Edzo Lagoon improvements: Reduced from \$190,000 to \$150,000
- Water Truck: Increase from \$168,446 to \$204,660
- Sewage Truck: Increase from \$167,660 to \$169,131

#### CPI:

- Wireless Radio Project (for internet connectivity): We dropped this project as we are working with Northwestel for Fiber Optic connection. The budget of \$50,000 for this project will be used for other projects.
- Fuel Tank with Card lock system: The budget was based on one tank (used), and now we will get two brand-new tanks, one for diesel and one for gasoline, with larger capacity. The anticipated cost will be \$90,000 compared to the previous budget of \$50,000.
