Changes to the Terms of Employment Bylaw 31-2012 include the following:

1. Probationary Period

- 3. Sick Leave
- 2. Notice of Termination of Employment
- 4. Grievance Procedure

Legislative changes **Affecting Terms and Conditions of Employment:** Amendments to the Act that came into force January 1, 2020.

- 1. Extended Parental Leave
  - Extended from thirty-seven (37) weeks to sixty-three (63) weeks
- 2. Extended Compassionate Care Leave
  - Extended from eight (8) weeks to twenty-seven (27) weeks
- 3. Family Caregiver Leave
  - Is a new leave under the Act.
- 4. Family Violence Leave
  - Is a new leave under the Act.
