

## Community Government of Behchokò BYLAW NUMBER 148-16

A bylaw of the municipal corporation of the Community Government of Behchokò in the Northwest Territories, pursuant to the provisions of the *Tł*Įcho Community Government Act, S.N.W.T., for the purpose of repealing redundant bylaws.

**WHEREAS** the Tłįcho Community Government Act, S.N.W.T., 2004, provides authority for a community government to make bylaws Council considers appropriate;

**AND WHEREAS** the Bylaws listed in Article 2.1 are no longer deemed necessary or in the best interests of the residents of Behchokò;

**NOW, THEREFORE,** the Council of the Community Government of Behchokò, in regular session, duly assembled, enacts as follows:

## 1.0 CITATION OF BYLAW

1.1 This bylaw may be cited as the "Repeal of Redundant Bylaws Bylaw"
