



Community Government of Behchokò

BYLAW NUMBER 151-16

A bylaw of the municipal corporation of the Community Government of Behchokò in the Northwest Territories, pursuant to the provisions of the *Tłı̨chq̓ Community Government Act*, S.N.W.T., for the purpose of disposing of vehicles and equipment that are no longer repairable or functioning.

WHEREAS the Tłı̨chq̓ Community Government Act, S.N.W.T., 2004, provides authority for a community government to make bylaws Council considers appropriate;

AND WHEREAS the Community Government of Behchokò is required to maintain a list of capital assets for insurance and financial reporting purposes;

AND WHEREAS the Community Government of Behchokò finds that some of these capital assets are no longer useful, repairable nor can they be sold for any value;

NOW, THEREFORE, the Council of the Community Government of Behchokò, in regular session, duly assembled, enacts as follows:

1.0 CITATION OF BYLAW

1.1 This bylaw may be cited as the "*Disposal of Assets Bylaw*"

2.0 APPLICATION OF BYLAW
