



Community Government of Behchokò

BYLAW NUMBER 162-18

A bylaw of the municipal corporation of the Community Government of Behchokò in the Northwest Territories to provide for Municipal Service Rates, pursuant to the provisions of the *Tłıchq Community Government Act, S.N.W.T., 2004, c.7.*

WHEREAS the *Tłıchq Community Government Act, S.N.W.T., 2004, c.7*, provides authority for a community government to make bylaws Council considers appropriate;

AND WHEREAS Council deems it prudent to subsidize the cost of water, sewer and garbage collection for certain not-for-profit Non-Government Organization (NGO) facilities that provide for the homeless in the Community Government of Behchokò;

AND WHEREAS Council at this time deems this assistance should be directly solely to the Catholic Church, the Tłıchq Christian Fellowship, the Friendship Centre, and the Warming Centre,;

NOW, THEREFORE, the Council of the Community Government of Behchokò, in regular session, duly assembled, enacts as follows:

1.0 CITATION OF BYLAW

1.1 This bylaw may be cited as the "*Compassionate Service Utility Subsidy Bylaw*"

2.0 DEFINITIONS

2.01 "Catholic Church" means the **St. Michael Parish** as it is known at this date;

2.02 "Community" means the geographic area under the jurisdiction of the Community Government of Behchokò;

2.03 "Friendship Centre" means the **Tłıchq Leagia Ts'iili Ko Rae-Edzo Friendship Centre** as it known at this date;

2.04 "Tłıchq Christian Fellowship" means the **Tłıchq Baptist Church** as it known at this date;

2.05 "Warming Centre" means the Warming Centre as it known at this date;

3.0 Water & Sewer Rate Adjustments

3.1 That the current rates for Water & Sewer services shall be amended to charge a rate not to exceed \$1.00 per month for the Catholic Church, the Tłıchq Christian Fellowship, the Friendship Centre, and the Warming Centre.

3.2 Administration shall provide a report to Council annually, each January, so that Council can determine, on a facility by facility basis, whether this utility reduction benefit can be continued the following year.

4.0 GENERAL


4.1 Schedule "A" of Bylaw 146-16 is hereby amended to reflect this change in levy.

4.2 This Bylaw shall come into effect upon Third and Final Reading.


