Thcho Assembly 19th Session Directive November 3, 2008

The Thcho Assembly held its 19th Session in Behchokò on October 28 – November 3, 2008 and made the following decisions.

1. Extension of Assembly session:

The 19th Session of the Thcho Assembly is extended to include Friday October 31 and Monday November 3.

2. Community Government land leases

Legal Counsel Rick Salter and the former Thcho Agreement Negotiators will do a presentation on this issue at the next session.

3. Recommendations and policy direction from 4th Annual Gathering

The summary list will be discussed at the upcoming planning workshop.

Elders Advisory Council will be consulted on the Government of the Northwest Territories (ENR) request to increase Satellite Collars deployed on Bathurst Caribou females from 20 to 30 and will make a recommendation back to the Thcho Assembly.

- f) November 25, 2008 Afternoon Two applicants will be interviewed.

- h) November 26,2008 Afternoon Successful applicant will be selected by the committee.
- i) December 1, 2008 Allan will conduct reference checks on successful applicants and report to committee
- j) December 5, 2008 Committee will negotiate a contract with successful applicant.
