THE 2023 LAW TO AMEND THE TŁICHO LAND USE PLAN LAW

Title

1. This law shall be cited as the The 2023 Law to Amend the Tljcho Land Use Plan Law

Definitions

- 2. In this Law,
 - "Tłicho Assembly" has the same meaning as in the Tłicho Constitution.
 - "Tłicho Government" means the Tłicho Government and its institutions as defined in the Tłicho Constitution.
 - "Tłicho lands" has the same meaning as in the Tłicho Agreement.
 - "Tłicho First Nation" has the same meaning as in the Tłicho Agreement.

Preamble

- 3. WHEREAS on the effective date of the Tłįcho Agreement, Tłįcho Government, on behalf of the Tłįcho First Nation, was vested with title to lands totalling approximately 39,000 square kilometres, including the mines and minerals that may be found to exist within, upon or under such lands (Tłicho lands);
 - AND WHEREAS Thicho Government has the power to enact laws in relation to the use, management, administration and protection of the Thicho lands and the renewable and non-renewable resources thereon;
 - AND WHEREAS Tłicho Government enacted the Tłicho Land Use Plan effective April 25, 2013;
 - AND WHEREAS pursuant to 7.9 of the 2013 enacted Tłįcho Land Use Plan, a "Plan Review" was initiated by the Department of Culture and Lands Protection (DCLP) that re-evaluated the entire Tłįcho Land Use Plan. Recommendations from a special review committee called the "LUP Review Committee" (LUPRC) provided direction to DCLP staff. A series of comprehensive revisions to the Tłįcho Land Use Plan were developed through October, 2023;

AND WHEREAS Tłicho Government, with the advice and guidance of the LUPRC and DCLP, and after community meetings and other consultations and engagements, have completed a series of proposed revisions to the Tłicho Land Use Plan;

AND WHEREAS the proposed revisions are contained in the Tłıcho Land Use Plan that is attached as Schedule A to this law.

Tłicho Land Use Plan

- 4. The Tłıcho Land Use Plan Law is hereby amended by repealing Schedule A and replacing it with the Schedule A attached to this law.
- 5. The Tłicho Land Use Plan attached as Schedule A to this law is hereby in effect.

Coming into Force

6. This law shall come into force on October 13, 2023
