Tłicho Government

Terms of Reference: Tłįcho ?òhda Advisory Council

1. Purpose

As stated in the Tłycho Constitution:

"We follow in the footsteps of our ancestors and acknowledge our elders as the keepers of our living memory, self-determination, values and way of life. We honor and respect the truth of our traditional knowledge and oral history".

Therefore, as custodians of Tłįcho language, culture and way of life, the purpose of the Tłįcho Pohda Advisory is to share their wisdom, knowledge and experience, and to provide advice to the Tłycho Assembly and provide guidance on proceedings.

2. Membership/Appointment/Remuneration

The Tłıcho Pohda Advisory will consist of Tłıcho elders appointed as per the following:

- Grand Chief 2 Elders
- Behchokò Chief 2 Elders
- Whatì Chief 2 Elders
- Gamètì Chief 2 Elders
- Wekweètì Chief 2 Elders

Elders appointed to the Tłįchǫ ?ohda Advisory shall serve at the pleasure of the Chiefs Executive Council

Elders on the Tłįcho ?ohda Advisory will attend all sessions of the Tłįcho Assembly and other meetings, workshops, conferences and events as required by the Chiefs Executive Council, a Chief or Grand Chief.

Elders shall be paid honorarium and travel expense as per Tłįchǫ Government policies and procedures.

3. Administration

The Tłįcho Pohda Advisory shall be assisted by resource person where required.
