

**FIRST AMENDMENT TO
TŁIČHQ GOVERNMENT BUDGET LAW 2011 - 2012**

Title

1. This law may be cited as the *First Amendment to Tłıchq Government Budget Law 2011 – 2012*.

Definition

2. In this law,

“Proposed Budget” means the budget for April 1, 2011 to March 31, 2012 pursuant to *Tłıchq Finance Law* and prepared and recommended by the Chiefs Executive Council attached to this Law as Schedule A.

Adoption and Approval of the Budget

3. The Proposed Budget is adopted and approved as the budget of the Tłıchq Government for the period April 1, 2011 to March 31, 2012.

Coming into force

4. This Law shall come into force on November 17, 2011.

This Law was signed by Grand Chief Eddie Erasmus on November 17, 2011.
