


## TŁICHQ GOVERNMENT

# **TŁIČHŦ ASSEMBLY MEMBERS AND CHIEFS TRANSITION ALLOWANCE LAW**

## **Title**

1. This law may be cited as the *TłıchŦ Assembly and Chiefs Transition Allowance Law*.

## **Definitions**

2. In this law the definitions shall have the same meaning as the *Tlıcho Assembly and Chief's Executive Council Law*.
3. "Annual Salary" means:
  - a. For a member of the Assembly - the base plus other amounts referred to in Sections 1 and 4 of Schedule A to the *TłıchŦ Assembly and Chief's Executive Council Schedule B Amendment Law 2005*.
  - b. For a Chief - the annual remuneration referred to in Sections 2 and 4 of Schedule A to the *TłıchŦ Assembly and Chief's Executive Council Schedule B Amendment Law 2005*.
  - c. For the Grand Chief the annual remuneration referred to in Sections 3 and 4 of Schedule A to the *TłıchŦ Assembly and Chief's Executive Council Schedule B Amendment Law 2005*.

## **Transition Allowance**

4. A member of the Assembly or a Chief, including the Grand Chief, shall be paid a transition allowance equal to one-twelfth of their Annual Salary for each consecutive year of service, if he or she:
  - (a) resigns his or her seat as a member of the Assembly, as a Chief or as Grand Chief;  
or
  - (b) is serving as a member of the Assembly, as a Chief or as the Grand Chief immediately before that Assembly is dissolved or is ended by the passage of time, and he or she does not become a member of the Assembly, a Chief or the Grand Chief of the next following Assembly.

### **Calculation rules**

5. For the purposes of this Law, the Annual Salary in respect of a person is the amount referred to in section 3 calculated annually for each year the person was a member of the Assembly, a Chief or a Grand Chief.

6. A transition allowance under section 4 shall be calculated pro rata for any period of service less than a year and without regard to any period of service before August 4, 2005.

7. If a person has served in more than one of the roles of member of the Assembly, Chief or Grand Chief in consecutive years, the calculation of Annual Salary shall be made based on the time period that the person has served in each of those roles.

### **Coming into force**

8. This Law shall come into force on the date when the Grand Chief signs this Law.
